## **Abstract**

The necessity for Ukraine's entry to the European community and various international organizations requires the acceleration of economic reforms, the transformation of market relations, and so on. Ensuring of sustainable social and economic development of Ukraine and its regions is associated with addressing important issues in the economic, social and legal spheres. One of the central issues that needs to be addressed at the state and regional levels is the reform of national and regional labour markets. This publication aims to establish the structural and dynamic features of the regional labour market in Ukraine on the example of border north-western Volyn and north-eastern Kharkiv regions.
